#### John C. "Jack" Bierwirth



Jack Bierwirth, our former chairman and chief executive officer, passed away on Sunday, May 26, of congestive heart failure.

Born on Long Island on January 21, 1924, he served in the U.S. Navy during World War II, reaching the rank of lieutenant junior grade. After the service, he went on to earn a bachelor's degree from Yale, where he was a pitcher on the baseball team. Jack also received a law degree from Colombia.

Jack joined Grumman Corporation in July 1972, as vice president - Finance. One of his first tasks was to rework contracts with the Navy to help the company avert a potential bankruptcy. That November, he was elected president of Grumman Corporation. Two years later, he was elected chief executive officer. The company's board voted him chairman, effective January 1, 1976. Jack retired on August 1, 1988.

Though Grummanites at that time remember his leadership, and Retiree Club members of the Long Island chapter know him for his attendance at club events, little is known to many people about Jack's extensive work for peace, the environment, and international business.

For example, he was part of the U.S./Chinese effort to persuade the Russians to leave Afghanistan. He later joined Cyrus Vance and Brent Scowcroft as they worked with the People's Republic of China to further peace in East Asia.

In 1983, President Reagan appointed Jack to the 18-member panel of an international private enterprise task force. The panel was created to advise the president and the directors of the Agency for International Development on the role private enterprise can play in foreign aid.

Also that year, he was appointed to the New York State Council on Fiscal and Economic Priorities to advise then-Governor Mario Cuomo.

Jack is survived by his wife, Marion, of 66 years and their four children, John E., Warren M., Marion B. Woolam and Susan B. Arbios, and children-in-law Jane Bierwirth, Chris Woolam, and Bill Arbios. There are nine grandchildren, one granddaughter-in-law, and two great-grandchildren.

The members of the Grumman Retiree Club extend their most sincere sympathies to all of Jack's dear family. We also express our deepest gratitude for all that Jack did for the company overall, and for each employee for whom he worked so hard. Our thanks go to his family for their support of Jack during his years at Grumman.

#### Postscript, by Retiree Club President John Vosilla:

Several days after I submitted my June message to the newsletter editor, I learned the sad news that our former chairman, Jack Bierwirth, had passed away.

I was lucky enough to work in the Public Affairs departments of Grumman Aerospace and Grumman Corporation under several wonderful executives. Jack was one of them. It seemed he was always smiling, pleasant to everyone, unpretentious – remember the Checker [a car seen most on NYC streets as a taxi] he drove? Later, I had the pleasure of sitting with him at several Retiree Club holiday lunches. Talking to him was like talking to anyone I'd worked with over the years: simply pleasant.

A quote in Jack's *Newsday* obituary (there was also an obituary in the *New York Times*) said that the company lost money on some of the diversifications he initiated. True, but I know that those solar panels were great products because, years after the government pulled the tax rug out from under that market, people were still calling me, looking for spare parts. Grumman's *Sunstream* solar panels were still working and still saving their owners money.

The buses? Hey, if it weren't for New York City's horribly potholed streets – and they were horrible – maybe we'd still be building them, because they were running for years in other cities.

The Postal Vehicles were the biggest single contract the company had won to that point in its history, and many are still going. Money losers or not, my sense is that those "not our business" initiatives were simply Jack trying to find new opportunities for our talented workforce. To me, he cared.

Rest in peace, Jack. We'll miss you at the holiday luncheon this year, and always.

#### Northrop Grumman News

#### \$4 Billion Share Repurchase — Will Retire 25% of Outstanding Shares

May 16 2013: The board of directors has authorized an additional \$4 billion for the repurchase of the company's common stock, for a total repurchase authorization of approximately \$5 billion. The goal is to retire approximately 25 percent of shares outstanding by the end of 2015, market conditions permitting. As of March 31, 2013, the company had approximately 235 million shares outstanding.

#### **Eleven Percent Dividend Increase Announced**

May 15, 2013: The company's board declared a quarterly dividend of \$0.61 per share on Northrop Grumman common stock, an 11 percent increase from the prior quarterly dividend of \$0.55 per share. This is the tenth consecutive annual increase in Northrop Grumman's quarterly common stock dividend. The dividend is payable June 12, 2013, to shareholders of record as of the close of business May 28, 2013.

#### X-47B Catapults From Carrier Into History Books

May 14, 2013: Northrop Grumman and the U.S. Navy launched a new chapter in the history of unmanned systems – carrier-capable unmanned aircraft – by successfully catapulting the X-47B Unmanned Combat Air System (UCAS) demonstrator from the deck of the *USS George H.W. Bush*. The X-47B was launched while the carrier was under way off the coast of Virginia. The tailless, strike-fighter-sized aircraft flew autonomously back to Naval Air Station Patuxent River where it landed safely 65 minutes later.

"Today's catapult launch of the X-47B is a momentous feat for naval aviation," said Capt. Jaime Engdahl, Navy UCAS program manager for the Naval Air Systems Command. "It proves that the Navy's goal of operating unmanned systems safely and effectively from aircraft carriers is well on its way to becoming a reality."

#### **Company Completes Lunar Lander Study**

The company completed a feasibility study for a new commercial lunar lander for the Golden Spike Company (GSC). The study confirmed the viability of lander concepts for Golden Spike's human lunar expedition architecture and conceived a novel new, low-mass ascent stage concept dubbed "Pumpkin."

A few of the tasks that Northrop Grumman studied for GSC were:

- + Established propulsion requirements for lunar orbit loiter, descent to the lunar surface, ascent to low lunar orbit and rendezvous with a crew vehicle for pragmatic lunar landing sites.
- + Developed current and stretch factors to reflect the improvement in relevant technologies since the completion of the Apollo program.

+ Evaluated 180 lunar lander cases for various options and sensitivities including loiter, staging, propellants, engines, surface duration, surface cargo and technology basis.

The study determined that for GSC's mission architecture, there are many more options for all cryogenic propellants compared with storable propellants, but that multiple storable propellant options are possible. Cryogenic propellants have higher performance, but are more difficult to contain for the GSC mission duration than storable propellants such as those used in the Apollo program.

#### **Bethpage Chapter Meeting**

At noon sharp, President John Vosilla welcomed the attendees to our May 22 pre-meeting luncheon held at the Crest Hollow CC. Thanks go to past-President Marion Abbott for making all the luncheon arrangements.

The president called the meeting to order at 1:30PM. The Pledge of Allegiance was led by past-President Abbott and was followed by a moment of silence for our deceased members, our armed forces throughout the world, and for the residents of Moore, OK, who survived that horrendous EF-5 tornado, a storm was described to have substantially more energy than the atomic bombs that ended WW II.

The president asked for corrections or additions to the April minutes as published in our newsletter. There being none, the minutes were accepted as printed.

John then asked for first-time visitors and first-time new members in attendance. There were three first-time members, including Norm Dvoskin who, since leaving Grumman, has been a meteorologist on News 12, the local cable TV channel.

1st VP Bob Ripp introduced guest speaker Michael Cooney, now semiretired and working as director of Special Projects for United Way of Long Island. He lives in Massapequa Park with his wife Monica, and will be celebrating their 44th anniversary this year.

Mike began by thanking all Grummanites for past contributions to United Way. He cited the fact that Grumman was the only company that ever gave United Way more than \$1 million in a year. He then tested our knowledge of Long Island's problems. "How many people on Long Island below the federal poverty level?" he asked. Shockingly, there are 168,000 peopleon LI below the poverty level. Long Island has the highest AIDS population of all communities in the country – triple the average. We also have a tremendously high number of child abuse cases. Mike said this is the United Way's new environment. Therefore, United Way of United States had to change its game plan a few years



back. The United Way used to give money to agencies like Blue Cross for them to use as they thought best, United Way now targets specific programs of the 110 different agencies that they try to support. These new contributions are made with three guidelines in mind. First, UW contributes to programs that increase people's financial stability. Second, to programs that increase healthcare availability to people. Third, to programs that increase education access for troubled youth to encourage graduation.

This change of business model started when UW helped form Mobile Health of Long Island. It consisted of two RVs. One was a pediatric office; the second, a dental office. Together they served 3,000 children and adults a year. Mike also described a program for troubled youth who, after training, rebuild homes that are then auctioned to a low- or moderate-income family.

Mike discussed many other programs they fund. One trains returning vets with marketable skills; another provides emergency heating fuel assistance and another gives Sandy Victims funds to cover losses that go beyond what FEMA or their insurance companies will reimburse. Those, along with others he described, and those he didn't, are accessible to everyone via a hot line. He also asked for our continued help, financially and as volunteers.

After a short Q&A session, John presented Mike with a token of the club's appreciation.

#### **Committee Reports**

Community Relations – Betty Bohlander itemized some of the organizations to which the club contributes. Since the beginning of 2013, we have contributed to the United Way of Long Island and just recently to Rebuilding Together LI for Hurricane Sandy victims. We also contributed to the fund raising gala of the Cradle of Aviation, which contains so many Grumman aircraft and products, and \$50 toward gifts at each of the annual blood drives. In the upcoming months, more donations will be made to various charities and we will try to include charities that serve the elderly, children in need, abused women, and our military personnel who

return home with severe injuries. Betty thanked everyone for the donations to the club, which will allow us to help others.

· Bob Ripp said he received a letter from the Northrop Grumman Benefits Center stating that the company will transition the prescription drug plan from Express Scripts to CVS Caremark. Bob spoke to CVS Caremark, and was assured that there would be a seamless transition. One change from Caremark's earlier policy: 90-day prescriptions with refills that were previously required to be filled only by mail can now be filled at any CVS pharmacy. A CVS Caremark ID card will be sent to each Rx plan participant. With the ID information, you can log onto "caremark.com" to set up your account password. The Express Scripts account password is not valid on the CVS Caremark web site. CVS Caremark will receive all prescriptions that still have refills from Express Scripts, except for controlled substances; CVS Caremark requires new prescriptions for those drugs. For individual questions, contact CVS Caremark at the telephone number in the letter. Bob also related that CVS Caremark will fill prescriptions with generic drugs unless your doctor specifically requires the use of the name brand drug only. Then, you will get the name brand drug but you will pay full price.

#### **FLORIDA / Space Coast**

President Bob Prais called our May 15th meeting to order greeting 72 members and guests. Following the Pledge of Allegiance led by VP John Lau, Ed

Romano reminded us of our many blessings as he led us in prayer. Our delicious two soups and fresh fruit salad starters were followed by the usual outstanding Suntree Country Club buffet.

Following the luncheon, VP John Lau introduced quest speaker Barbara Bergin, executive director of Central Florida "Crimeline." Barbara is a dynamic lady whose extensive and diverse police background includes serving 12 years as a homicide detective. Obviously highly motivated, "Detective Barb" is a dedicated saleslady for the unique Crimeline system for locating both criminals and crime sites by seeking out and rewarding "tipsters." At the start of this program in central Florida, there were 3500 tips per year. Now there are 10,000. The key factor is absolute anonymity of the callers -- there is no track. trace, or caller ID. Significant financial rewards are paid to the tipsters via an assigned special caller ID number. Phone calls are received 24 hours a day at a center in Canada, which relays them to our Crimeline center.

Our center serves 2.6 million people in six counties, awarding over \$271,000 last year, with some individual awards of \$5,000 paid to tipsters without requiring identification. Funds come from both contributions and court fines (after fees). Awards are non-taxable by the IRS. The 137 arrests last year yielded a half million dollars in recovered property plus \$12 million in drugs.

Predictably, the No. 1 subject for calls is drugs, both sales and use, with warrants running second. Violent crime, including murder, is third, with a recent tip yielding an arrest for double murder in less than eight minutes. Interestingly, "Detective Barb" identified women as the leading tipsters -- primarily ex-wives and girlfriends. Another major source of tips is the jails where the 800-number for tips is not blocked out.

This 35-year old, multistate program has now been expanded to include school campuses where the No. 1 problem is bullying. Surprisingly, the No. 2 problem is self-hurting, followed by vandalism and theft.

#### **Grumman History - Chapter 15**

#### Fly Me To The Moon (1961-1962)

Unperturbed, Grumman continued to perform well in 1961. But this quiet was like a calm sea hiding an underwater storm. For example, there was the announcement of the delivery of eight transportable mobile pilot ready rooms using Aerobuilt Body trailers; there was the "flying brain" Hawkeye, receiving a \$38 million production contract from the Navy; and the \$877,000 contract from NASA's Langley Research Center to develop and build the canisters and adapter for NASA's Echo II, a rigidized, 130-ft diameter spherical Mylar communications satellite. Performance continued ontrack when, in August, the hydrofoil ship *Dennison*, built for the Maritime Administration, was trucked overland on a 10-hour, 12-mile journey to Jakobson's Shipyard in Oyster Bay for final fit-out and assembly.

CEO Clint Towl, delivering his first year-end speech, summed up 1961 by noting the significant line up of production and development projects underway: the S2F-1 (completed), and S2F-3 Tracers, the WF-2 Tracker and its replacement the W2F-1, Hawkeye, the AO Mohawk, the Albatross, the Ag-Cat and the Gulfstream for the commercial market, and the OAO and Echo II canister space projects. Investment in technical capability was expanding with the opening of the \$2.5 million Space Environment Testing Area and the \$5 million Electronic Systems Center (Plant 14). Towl concluded by saying that Grumman had the most stable work force in the industry because it delivers quality products on time and at lowest cost. The people had to continue to maintain this performance to remain competitive.

Towl did not talk about the firmament under the surface such as the co-led effort by Tom Kelly and Tom Saniel to develop lunar mission concepts and how that effort "took off" in response to President John F. Kennedy's May, 1961, announcement that the United States was going to initiate a project to land men on, and return them from, the moon by the end of the decade. Nor did he mention the difficult decision to become a subcontractor to General Electric rather than prime Apollo, as the program risk was tantamount to betting the company on this huge, complex project. The Apollo proposal was submitted in October and by November the severely disappointed team learned of their loss to North American Aviation. But this was not all. Simultaneously, an independent Grumman group was hard at work with teammate General Dynamics seeking to win the huge new multibillion dollar, Air Force-Navy, swing-wing, two-man, supersonic TFX fighter.

Undaunted by the Project Apollo loss, Grumman's "persistence-gene" emerged. The Grumman space team felt they could still win a big piece of Apollo if they pursued the Lunar Orbit Rendezvous (LOR) approach for the landing mission and then win the contract for the lander. With company funding, this strategy was vigorously pursued. The team conducted and presented studies to NASA on the advantages of LOR, lunar lander concepts, and issue-potential solution sets, thereby establishing itself as a leader in understanding the complexities of designing the lunar lander.

While Tom Kelly was on his way to becoming the "Father of the LEM," he also should be remembered as an advocate for automobile seat belts. In December 1961, Tom's co-leader Tom Saniel was tragically killed in an automobile accident. The shock of this incident had barely worn off when Tom Kelly's car was hit from behind, flipping it over, doors flinging open, windows smashing, then skidding on its roof, and re-flipping again. Tom walked away and credited his seat belts with saving his life. This story was covered in *Plane News* where he encouraged Grummanites to install seat belts that were available at steep discounts from the Safety department. [Ken, one of the authors of this article, bought his seat belt after reading that article.]

Increasing international business led to the creation of Grumman International, Inc., with Lew Evens as president, in January. Later in January, *Plane News'* lead story was by Clint Towl, announcing the failure of a union to organize the 170-man heating/air conditioning maintenance operators by a vote of 152-15. You could sense Grumman management's sigh of relief. Technical capability had received another boost In May, when Grumman announced the building of a modern \$5 million Space & Missile Center. With just the steel frame standing, this partially built structure was featured in Grumman's LEM proposal.

Sadly in July, after a short illness, Roger Wolfe Kahn, Grumman's director of Service and Product Support, passed away. Within Grumman, he was known for creating the service function and then growing it into an organization that provided worldwide product support. His diminutive stature belied his amazing achievements as a nationally renowned musician/composer, and an extraordinary pilot who logged over 7,000 hours including many as a Grumman test pilot. He was associated with such greats as Tommy Dorsey, Artie Shaw, Glen Miller, Charles Lindburgh, and Jimmy Doolittle.

While all these events took place, the LEM and TFX proposal efforts soldiered on. Then, it happened. On November 9 a special edition of *Plane News* hit the street. Grumman had been selected by NASA (Nov. 7) to negotiate for the Lunar Excursion Module (LEM). The tremendous effort, put forth by the largest Grumman technical team ever assembled, had paid off. The results of 16-hour workdays and seven-day workweeks were summarized in just 110 pages in the \$344 million proposal. Reminiscent of a James Bond novel, Saul Ferdman never took his eyes off the proposal, which was due September 2, watching it being loaded on the airplane, locking himself and the proposal in his Washington hotel room overnight until its delivery to NASA's Jim Neal two hours early.

The LEM contract changed Grumman. It fostered diversification, it was the first time a non-aircraft product was its largest single contract, and Grumman's reclusive posture in the industry would be shed, as the world would look to Grumman to "fly me to the moon."

Good fortune struck again on November 24, 1962. The Air Force selected the General Dynamics - Grumman team to develop and produce the TFX (F-111) Air Force-Navy fighter. Grumman, as principal subcontractor, would be responsible for producing the aft sections for all the versions of the F-111; for producing the entire assembly of the F-111B Navy version; and for the integration of all Navy-type electronics. The contract also called for the production of 23 aircraft.

November 1962 - two giant wins – a month for the Grumman record book.
