Our guest speaker, Eric Boehm, Curator of Aviation at the Intrepid Museum. was introduced. Eric said that he grew up around aircraft, his father having been a WW2 Avenger turret gunner. Photos of Grumman planes were all around his home. Furthermore, he spent 20 years in the Air Force as an aircraft mechanic, followed by museum exhibit fabrication experience that ultimately brought him to the Intrepid Museum.

After a brief history of the Intrepid from WW2 through Viet Nam, Eric provided an overview of the thrust of museum activities for the million or more visitors each year and included lots of interesting stories about each activity. He told us about:

<u>Special Programs</u> for NYC disadvantaged children, children with autism, children that are blind, and seniors with dementia.

Exhibits, including an aircraft collection comprised of tens of restored aircraft and helicopters, both domestic and foreign. The foreign exhibits are from Italy, the United Kingdom, Israel, France, Poland, and North Viet Nam. The US service exhibits include the Grumman Avenger, Cougar, Tiger, Tracer, Intruder, and Tomcat. Larger exhibits include the Space Shuttle Orbiter Enterprise (on display in the Shuttle Pavilion), the A-12 Blackbird, the Concorde, and the Growler. The Growler is an American guided missile submarine, which offers visitors a firsthand look at life aboard a submarine and a closeup view of the once top-secret missile command center.

<u>Simulators and Video Programs</u>, showing behind the scenes operations, tour guide talks, Intrepid education, Museum News and Events, and Special Event Venues (parties, weddings, etc.).

In conclusion, Eric thanked all Grumman retiree volunteers for their tireless efforts to keep the exhibits ship-shape. He specifically thanked Retiree Club member and Northrop Grumman employee Jim Eng for his efforts.

The members expressed Thanks to Eric, and VP Pat Sullivan presented a commemorative plaque and medallion, with all Grumman aircraft shown, to Eric as a memento of his time with us.

#### April 25, 2018

The facility-packed crowd of retirees, a 2018 record, was rewarded with an entertaining and informative speaker who kept the attention of our attendees for over an hour. Following the Pledge, the prayer, and our usual varied buffet, President Bob Prais introduced our speaker, Mark Rutledge, of the Crime Prevention Task Force. The CP Task Force is a 22-year-old community service organization developed by former law enforcement officers (local and state police, FBI, CIA, etc.) to make the public aware of the increasing criminal threat in our communities. The Task Force also highlights

procedures to avoid and counteract many of the threatening activities.

The first matter of import is Awareness, as history has shown that 74% of this type of localized criminal activity could be avoided. He indicated that the No. 1 city in the USA for criminal activity is Miami, with Tampa No. 2. The Murder Capital, Chicago, trails as No. 3. In fact, eight of the top crime cities are in Florida where burglary is growing 37% faster than the population growth!

As Mark related that the biggest increases in criminal activity were in purse snatching and armed robbery, he switched over to another aspect of the CP Task Force's activity: resistance and active deterrence. The first order being: "Let go of the purse" — but have your valuables (cash, credit cards, jewelry) located in a safer place such as a purse "necklace." Add a noise maker device to a "purse string." Mark also dwelled on various supermarket scams including devices which could record your ATM info as you were remotely locking your car doors.

After reviewing the variety of household defenses, Mark displayed a new, low-cost wireless system, which works on air pressure changes and monitors every external opening in the house. His closer was a discussion of pepper sprays including one used by park rangers in Yellowstone Park to stop enraged grizzly bears in their tracks. The mini mob scene around Mark at the close of his presentation was testimony to the avid interest he generated with his fact filled talk.

<u>Treasurer's Report:</u> Bill Waldron's monthly status report indicated that both General and Scholastic accounts were in healthy shape as we approach the significant expenditures anticipated for our two new scholarship winners,





plus our prior year scholars. Bill then introduced our three new members:




